As I have ended each year's message, thank you for supporting WCEC and please call me if you need me.



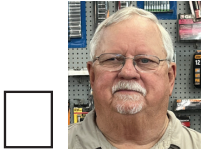

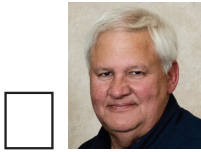

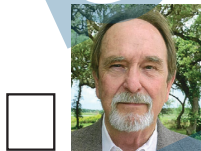

MINUTES OF 2023 MEETING OF MEMBERS

Wharton County Electric Cooperative, Inc. held its 85th annual membership meeting Wednesday, May 31, 2023 at the El Campo Middle School (ECMS) in El Campo, Texas. The school was chosen for its capability of allowing numerous vehicles in the registration line without hindering through traffic on the street. On May 1, 2023, each member of the cooperative was mailed, in the 85th Annual Meeting brochure, an Official Notice of Annual Meeting of Members to be held May 31, 2023.

In light of the continuing success of drive-through annual meetings over the past three years, the Board of Directors of Wharton County Electric Cooperative, Inc. voted to again hold the annual membership meeting as a "drive-through." No meal was served.

Registration began at 3:41 PM. Upon entering the ECMS driveway, members paused at one of two registration tents where WCEC employees registered members and gave them a two-part ballot. The first part of the ballot was the Election of Directors; the second part was the Approval Ballot allowing members to approve the Minutes of the 2022 Annual Membership Meeting, the 2022 Financial Report, along with the President's Message and Manager's Report.

Members then drove to the front of the building for the second stop. Here each voting member received an attendance gift of an umbrella. Any children in the vehicle also received an attendance gift, which was a soft backpack.

As members continued driving forward, the third and last stop was the ballot drop-off area. Here the Ballot Committee collected the ballots, and members then exited the parking lot.

At 7:00pm sharp, no further entries were allowed into the parking lot. Any members still in line were allowed to register and vote.

After all ballots had been collected, they were directed to the WCEC Thomas Edison Room to count the ballots with the assistance of Patsy Metting, Manager of Accounting, and Cynthia Hernandez, Accountant. The Ballot Committee consisted of Joey Polak, District 1; Madelyn Zbrank, District 2; Frankie Peter, District 3; Debbie Lutringer, District 4; Barney Douglas, District 5; Donna Wessels, District 6; Tiffany Alley, District 7; and Mary Lou Ellett, District 8. The District 9 representative was absent. The Director Nominees were:

- District 2 – Kurt Ilse; Patrick Kubala, Incumbent
- District 5 – Brett Rachune; Samuel Craig Hardin, Incumbent
- District 8 – Robert Krenek, Jr.; Jim W. Harton, Incumbent
- District 9 – George "Buddy" Dornak, Jr.; Gary Lamberth

Members of the Ballot Committee noted that there was a discrepancy on the Voting Ballot regarding "Incumbent." The committee discussed and agreed to proceed with counting the ballots. Immediately after all ballots had been counted, Ballot Committee Chairman Donna Wessels certified winners of the Director Election. Those elected by simple majority vote were:

- District 2 – Kurt Ilse
- District 5 – Samuel Craig Hardin
- District 8 – Jim W. Harton
- District 9 – George "Buddy" Dornak, Jr.

General Manager/CEO Gary Raybon called all candidates and notified them of the results.

The Approval Ballots were tallied with the following results:

- The Minutes of the 2022 Annual Membership Meeting were approved.
- The 2022 Financial Report was approved.
- The President's Message and Manager's Report were approved.

Each registered member will receive a \$20.00 bill credit that will be applied to the June billing period. A drawing for thirty-one (31) prizes took place on Thursday, June 1st at the WCEC headquarters office on Facebook Live. All entries were included for the final grand prize drawings. Grand prize winners were:

- \$100 free electricity – Dustin Flagg
- \$150 free electricity – Daniel Gutierrez
- \$200 free electricity – Gary Meek
- \$300 free electricity – Linsey Aguilar

The final count of voting members was another successful record of 838.

[NOTE - Subsequent to the Annual Meeting, it was discovered that Mr. Ilse was not eligible to serve as a Director on the WCEC Board. The Board met on June 5, 2023 and passed a resolution declaring Mr. Kubala the winner of the election. Mr. Kubala will serve as the District 2 Director for 2023-2026.]

INDEPENDENT AUDITOR'S REPORT

Wharton County Electric Cooperative, Inc.

Opinion: We have audited the accompanying financial statements of Wharton County Electric Cooperative, Inc., which comprise the balance sheet as of December 31, 2023, and the related statements of revenue and patronage capital, and cash flows for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of Wharton County Electric Cooperative, Inc. as of December 31, 2023, and the results of its operations and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion: We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Wharton County Electric Cooperative, Inc. (the Cooperative) and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements: Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Cooperative's ability to continue as a going concern within one year after the date the financial statements are available to be issued.

Auditors' Responsibilities for the Audit of the Financial Statements:

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with GAAS we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Cooperative's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Cooperative's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.
